WHAT CAN WE EXPECT FROM PRIME MINISTER ROWLEY'S OFFICIAL OVERSEAS VISITS?

What it all means for T&T.

The Government, led by Prime Minister Dr. the Honourable Keith Rowley, is on a mission to improve every facet of our twin-island republic. An integral element of this national rejuvenation is the strengthening of Trinidad and Tobago's relationships with our regional and international counterparts.

As the Head of Government, Prime Minister Rowley has spearheaded this initiative. In May 2016, Prime Minister Rowley undertook an official trip to the United States of America, Ghana and the United Kingdom. During this time, he engaged with several world leaders and represented Trinidad and Tobago in a number of important fora. But what does the country stand to gain?

• Maintenance of Diplomatic Relations

The ever observant global community is constantly assessing the stability of nations, particularly during the period subsequent to an election. Working visits such as these illustrate that Trinidad and Tobago is not only stable but prepared and capable of conducting business. It allows our leaders to emphasise and re-iterate commitments to mutual causes and joint efforts and ensures that Trinidad and Tobago is a part of global consultation and decision making.

• The Expansion of Trade

Working visits can also yield avenues to expand the local economy by creating access to foreign markets and joint endeavours. For example, Trinidad and Tobago and Ghana signed a General Cooperation Agreement on energy, a highly profitable industry. The Prime Minister also received two (2) delegations from Nigeria to discuss opportunities for future cooperation.

• Additional Avenues for Investment

Dr. Rowley met with the head of the Carlyle group of companies, the President and senior executives of the International Development Bank (IDB) as well as executives of British Petroleum (BP). During these meetings, the potential for increased foreign investment in Trinidad and Tobago was high on the agenda. Dr. Rowley also took part in the US-Caribbean-Central American Energy Security in Washington D.C. This is of great significance when one considers that Trinidad and Tobago's economy is heavily based on the energy industry.

• Collaborative Efforts

In addition to the Energy Summit, Prime Minister Rowley also participated in the Anti-corruption Summit hosted by the Prime Minister of Great Britain David Cameron in London. More recently, the Prime Minister attended the Seventh Summit of Heads of State and/or Government of the Association of Caribbean States (ACS) in Cuba.

At these platforms, small developing states such as Trinidad and Tobago, are able to band together and prepare for challenges which can be better addressed as a united force.

Prime Minister Rowley also met with the President of Howard University, Dr Wayne Frederick. The discussions at this meeting centred on the opportunity for Trinidad and Tobago and Howard University to collaborate in the areas of health care training and other human resource issues with a view to improving health care delivery in Trinidad and Tobago.

• Reaching out to the Diaspora

The Prime Minister also took the opportunity to engage with members of the Trinbagonian diaspora when he delivered the feature address at the Medgar Evers College Inaugural International Education Awards Presentation Ceremony. The efforts and contributions of nationals who live abroad must not only be recognised but encouraged as we seek to establish long-standing revenue streams.

BUILDING STRONG LEADERS

The OPM, in conjunction with the Ministry of Public Administration and Communications, recently conducted a workshop, the main theme of which was “Reflection”.

The workshop was held from June 29th– July 1st, 2016 and was repeated from July 13th – July 15th 2016 in order to capture all Permanent Secretaries, Deputy Permanent Secretaries and Heads of Departments of the Public Service.

The workshop addressed the following competencies:

1. Reflective Self-Awareness Competency
2. Leadership for Results
3. Integrity and Respect Competency

As part of the programme, six (6) retired Permanent Secretaries were asked to share their experiences and offer guidance to those present. The workshop was lively and involved active participation by the attendees.

The facilitator for this event was Dr. Roland G. Baptiste.

On the third day of the workshop, the Minister of Finance, the Honourable Colm Imbert, and the Minister of Planning and Development, the Honourable Camille Robinson-Regis made presentations to the attendees and opened the floor for questions.

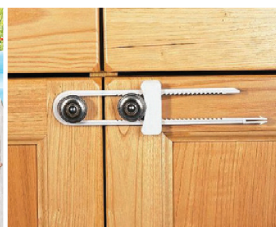

CHILDREN HAVE THE RIGHT TO PROTECTION AND THEREFORE NEED CONTINUOUS SUPERVISION AT ALL TIMES

■ NEVER LEAVE CHILDREN ALONE

Always check on your children, whether they are asleep, in a crib, bed or at play. Always keep your children within your eyesight.

Never leave children unattended near water. Drowning can occur in less than an inch of water, making bathtubs, sinks, pools, ponds and even buckets a source of great danger. It only takes a few seconds for drowning to occur.

Make sure you have a fence around the pool or pond to keep young children from wandering around these areas. Wading pools or splash pools should always be emptied when playtime is over.

■ KEEP CLEANING MATERIALS AND OTHER CHEMICALS AWAY FROM CHILDREN

Many household products are potentially poisonous to children if swallowed or inhaled. Children are naturally curious. It is the adult's responsibility to keep these substances locked away or out of the reach of children, such as on high shelves.

Install cabinet guards on any cabinet where medicine, cleaners, chemicals or garden fertilizers are stored. Keep these products in their original container; do not store them in a container

where they might be mistaken for food. If an accident occurs, contact the Poison Hotline at 800-2PIC(2742).

Keep matches, cigarettes and lighters out of the reach of children. Monitor children closely around hot pots, lit ovens and irons.

■ KEEP SLEEPING AREAS AS BARE AS POSSIBLE, ESPECIALLY FOR BABIES

Keep your baby's crib as bare as possible. An infant's nose and mouth can be covered accidentally by soft fluffy pillows, comforters or stuffed animals, restricting their ability to breathe.

■ KEEP SMALL ITEMS AND FOOD OUT OF REACH

Most choking injuries occur with food items. Cut your children's meals and snacks into bite-sized pieces. Children are at risk from choking on small candies, nuts, hot dogs, grapes, carrots and popcorn. Keep these foods out of their reach.

Make sure small household items such as coins, buttons, jewelry, small balls and pins, are stored away from children's reach to avoid accidental choking. Don't select toys with many small parts. Look for labelling on toys with small parts that warn they are not safe for children under 3 years old.

■ BE PREPARED FOR AN EMERGENCY

Unfortunately accidents do happen. The best thing you can do is prepare yourself for an emergency. Here are some ways to be prepared:

- Learn Cardiopulmonary Resuscitation (CPR) and the abdominal thrust procedure (Heimlich manoeuvre).
- Assemble a first aid kit with emergency instructions.
- Keep important numbers near your phone such as poison control, your pediatrician, your work and cell phone numbers, and a neighbour or nearby relative.

As soon as your children are old enough to know their own names and addresses, teach them to dial 9-9-9 to call for help in case of an emergency.

During her time at the Ministry of Foreign Affairs as the Chief of Protocol, Mrs. Dorset was often required to liaise with the Office of the President. She fulfilled this requirement during the term of two Presidents - His Excellency Sir Ellis Emmanuel Innocent Clarke, TC, GCMG as well as His Excellency Noor Mohamed Hassanali.

Today, the OPM is also benefitting from her extensive wisdom and advice on such matters as Mrs. Dorset has authored a Protocol Manual for the Office of the Prime Minister.

With her many years of experience in the Foreign Service and later as Executive Assistant to past Presidents of Trinidad and Tobago –His Excellency Arthur Napoleon Raymond Robinson SC, OCC, TC and His Excellency Arthur Napoleon Raymond Robinson SC, OCC, TC – she has already offered the OPM staff a great deal of her vast reservoir of knowledge during the initial training sessions.

It is our hope that this training can be expanded to other ministries and state enterprises as Trinidad and Tobago works towards strengthening our regional and international foothold.

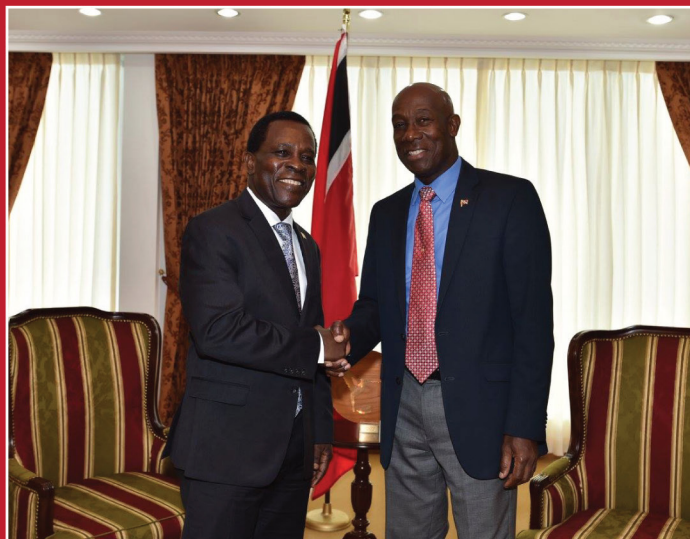

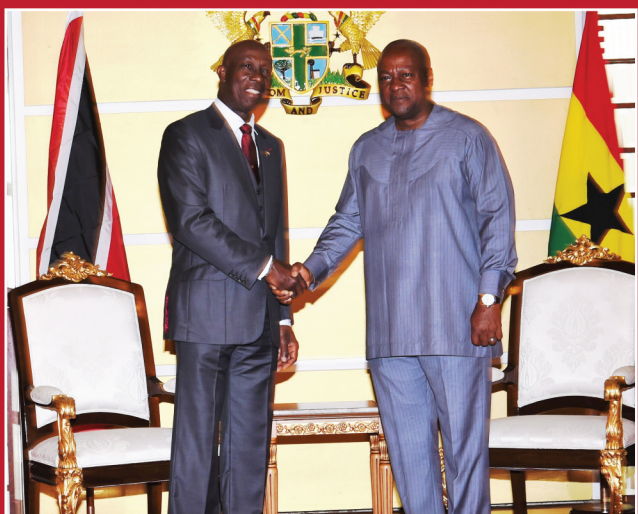

HAPPENING IN TOBAGO

DID YOU KNOW?

Upon taking office, the present Government declared that it will not support the degradation of legislation, in particular the Tobago House of Assembly (THA) Act, nor will it support the duplication of the statutory functions, powers or autonomy of the THA.

As a result, the Government mandated a review of the former Ministry of Tobago Development as well as the Human Capital Development Facilitation Company. A report (dated February 2016) was completed by Dr. Prince and Mrs. Ethel Hector-Berkley.

This is in keeping with the Government's efforts to facilitate the introduction of internal self-government in Tobago in the manner that best benefits our twin island republic.

PUBLIC SERVICE DAY 2016

On June 23rd, the Office of the Prime Minister (OPM) participated in the annual Public Service Fair. The fair has been held annually since 2012 in recognition of United Nations Public Service Day.

The Ministry of Public Administration and Communications invited all government ministries to showcase their respective initiatives during the week-long open house held at the NALIS building in Port of Spain. This year, the theme was Innovating for Excellence in Service Delivery.

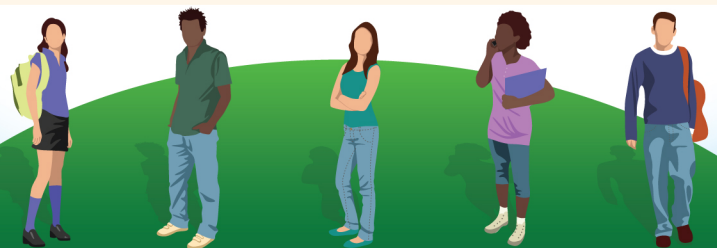

THE CABINET CORNER

Since the election of the new government, three (3) Committees have been commissioned by the Cabinet:

1. Committee to review the Levels of Health Care Delivery by the Regional Health Authorities and to rationalize the System of Public Sector Doctors in Private Practice (16th November 2015)
2. Committee to conduct a Holistic Review of the current Early Childhood Education and Primary School Education Curriculum (20th January 2016)
3. Committee to develop a refereed foundation Textbook on the History of Trinidad and Tobago (20th January 2016).

Featured Committee:

This quarter's featured Committee is the Committee to review the Levels of Health Care Delivery by the Regional Health Authorities and to rationalize the System of Public Sector Doctors in Private Practice.

Health care in Trinidad and Tobago operates under a dual system, that is, the co-existence of public and private health care facilities. While the overarching responsibility for health care lies with the Ministry of Health, the public service provision aspect was devolved to the Regional Health Authorities (RHA) with the passing of the Regional Health Authorities Act No. 5 in 1994.

It is highlighted in the government's policy that one of the key features in establishing a modern health care system is the development of "objective standards of care".

New systems to be developed must therefore strive to ensure that proper standards of care for the national health care system (public and private) are established, supported by the appropriate legislation, regulations and guidelines to make them binding on all health care practitioners

and institutions, in order to improve service delivery and accountability and to protect the public interest. In light of the foregoing the Prime Minister, through the Ministry of Health, established this Committee to review the current operating standards of the RHAs and their impact on its service delivery metrics. Additionally, the Committee will seek to rationalise the system and framework governing doctors who pursue private practice while in the employ of public institutions.

The Committee is required to review this operational conflict and its impact on healthcare delivery as well as to submit recommendations to resolve the situation. Ultimately, this will ensure that the nation receives the greatest value for financial investments in these professionals and institutions.

LEGISLATIVE PROGRESSES

The Government of Trinidad and Tobago is committed to ensuring that the laws of the land provide more than adequate protection to all citizens. This includes the amendment and introduction of laws to properly address the issues of the present time. Have a look at some of the latest legislative developments below.

- ***The Strategic Services Agency (Amendment) Bill, 2016 – Currently Awaiting Proclamation***

Extract: The purpose of the Bill, 2016 is to amend the Strategic Services Agencies Act, Chap.15:06 (SSA) to expand the remit of the Strategic Services Agency to include broader law enforcement co-ordination and intelligence functions. The Bill contains five clauses and, after it is passed, will come into effect upon Proclamation.

The aim is to broaden the definition of “serious crime” and establish a coordinated and integrated intelligence structure to deal with a wide range of crime and criminality, not solely drug-related activities.

- ***The Whistleblower Protection Bill, 2015 - Currently before a Joint Select Committee of Parliament***

Extract: An act to combat corruption and other wrongdoings by encouraging and facilitating disclosures of improper conduct in the public and private sector, to protect persons making those disclosures from detrimental action, to regulate the receiving, investigating or otherwise dealing with disclosures of improper conduct and to provide for other matters connected therewith.

The aim is to create an environment in which a) persons with knowledge of wrong-doings can safely come forward and disclose what they know and b) perpetrators can be held accountable.

- ***The Public Procurement and Disposal of Public Property (Amendment) Bill, 2015 – Committee Report Debated and Adopted***

Extract: The Bill seeks to amend the Public Procurement and Disposal of Public Property Act, 2015 to make provision for the removal of the Regulator by a tribunal, the establishment of a Public Procurement Review Board, the disposal of State Lands and other related matters.

The aim is to reduce avenues for fiduciary breeches and increase levels of accountability in government organisations.

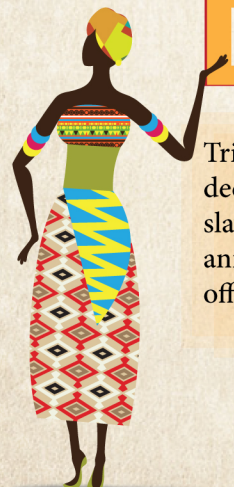
