Dear Secretary General

National Parliamentary Elections are scheduled to be held in Trinidad and Tobago on August 10, 2020. As you are aware, we have a long history of conducting free and fair national elections here in Trinidad and Tobago and have participated in many election observation missions within CARICOM and further afield.

The Government of Trinidad and Tobago extends an invitation to CARICOM to send an election observation mission under its auspices to observe our processes and operations in the upcoming Parliamentary Elections.

Given our management of the prevailing COVID-19 Pandemic the borders of Trinidad and Tobago remain closed. As a result, members of election observation missions would need to arrive in Trinidad and Tobago no later than July 24, 2020 to facilitate fourteen (14) days of state supervised mandatory quarantine.

Members of election observation missions therefore would need to apply for and obtain an exemption to enable entry into Trinidad and Tobago from the Minister of National Security of Trinidad and Tobago. In which case, a request for such exemption for persons from the sponsoring agencies on their behalf will be considered with dispatch.

The Government of Trinidad and Tobago would be pleased if our request for an election observation mission could find favour with CARICOM.

REQUEST FROM THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO FOR THE MOUNTING OF A CARICOM ELECTION OBSERVATION MISSION (CEOM)

- The Caribbean Community (CARICOM) Secretariat wishes to bring to the attention of Member States the attached letter dated 9 July 2020, from <u>Dr.</u> the Honourable Keith C. Rowley, Prime Minister of the Republic of Trinidad and Tobago, advising that National Parliamentary Elections will be held on **Monday**, 10 August 2020 and extending an invitation to the Secretariat to deploy a CARICOM Election Observation Mission (CEOM) to observe the electoral process.
- The Government of the Republic of Trinidad and Tobago has advised that, given the management of the prevailing COVID-19 Pandemic, the borders of Trinidad and Tobago remain closed. As a result, members of the CEOM would need to arrive in Trinidad and Tobago no later than 24 July 2020 to facilitate fourteen (14) days of state-supervised mandatory quarantine.

REQUEST FROM THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO FOR THE MOUNTING OF A CARICOM ELECTIONS OBSERVATION MISSION (CEOM)

- Members of the Election Observation Mission would also need to apply for and obtain an
 exemption to enable entry into Trinidad and Tobago from the Minister of National
 Security of Trinidad and Tobago. In which case, a request for such exemption for the
 designated persons will be considered with dispatch.
- 4. The CARICOM Secretariat invites Member States to identify suitable nationals to be members of the CARICOM Election Observation Mission (CEOM), and who are available between the dates of 24 July to 14 August 2020. Please note that only one (1) national per Member State is to be submitted for the CEOM, and that the individual nominated should be preferably a Senior Electoral Officer or very experienced in electoral monitoring.

[7/22, 1:31 PM] Larocque: Dear Minister, The request for nominees for the CARICOM Election Observation Mission for Trinidad and Tobago was circulated to member states by Savingram #408 on 10 July. The document informed of the quarantine requirement of two weeks. A reminder to member states was sent out on 16 July. To date three nominees have been put forward - Antigua and Barbuda, Barbados and Saint Lucia. I will keep you abreast of further developments with regard to fielding the observation mission.

[7/22, 1:37 PM] Larocque: Dear Minister, in addition to Colin Granderson's text message above which he shared with me, and following on our telephone conversation today, I have been advised that the cost of quarantine per member of the electoral obsrvation mission is US\$2,500. It is with much regret that I must inform you that we did not make budgetary provisions for the cost of quarantine. Any relief which could be provided in that regard would greatly facilitate the Missions visit.

[7/24, 11:16 PM] Dennis Moses: Let the potential members of the Election Observation Mission undergo the COVID-19 test as soon as possible so the 14 days can start. Give us the results. We will also test them on arrival. Let us get the CARICOM Election Observation Mission in Trinidad and Tobago as soon as possible.

[7/25, 7:53 AM] Larocque: We only have 3 members. I am not sure how effectively they will be able to observe polling day. We need a minimum 10, preferably 15, given the number of lolling stations and the geographical dispersion.

[7/25, 7:55 AM] Larocque: We need to have more persons on the ground.

Honourable Prime Minister,

I thank you for your letter of 9 July 2020, formally notifying me that National Parliamentary Elections are scheduled to be held on 10 August 2020, and inviting me to deploy a Commonwealth Observer Group.

As you rightly observe, the Commonwealth has a proud history of positive engagement with Trinidad and Tobago regarding election observation. The Commonwealth observed the 2000 and the 2015 Elections. Eminent Trinidad and Tobago nationals have served with distinction in Observer Groups across the Commonwealth.

While the COVID-19 pandemic poses unprecedented logistical and practical challenges, we are committed to making every possible effort to enable us to respond positively to your request for an observation mission and to assist Trinidad and Tobago in any way practicable. Thus, I have instructed my officials to work with your authorities to make every effort to overcome any logistical or other challenges in order to facilitate the presence of a Commonwealth Observer Group for the 10 August 2020 National Parliamentary Elections.

I note that your Government, as expected, continues to implement robust measures in response to the COVID-19 pandemic and that the current protocols require the Commonwealth Secretariat to apply to the Minister of National Security for exemption to be granted in order for election observers to enter Trinidad and Tobago, and that if this is granted fourteen days of state supervised mandatory quarantine are required. While the Commonwealth Secretariat would be able to meet the costs of the Observer Mission in the usual way, our current straitened financial position is such that we would not be able to provide funding to cover a fourteen-day period of quarantine. I have therefore instructed my officials to discuss this matter with yours, and it would be most helpful if the Government of Trinidad and Tobago were able to offer assistance.

My officials will be in touch with the Trinidad and Tobago Elections and Boundaries Commission in connection with necessary technical arrangements, and we should be most grateful if your Government would kindly nominate a separate focal point with whom Commonwealth Secretariat officials could liaise to discuss other necessary logistical arrangements pertinent to the COVID-19 environment. In this regard, I enclose an initial Information Sheet on matters which Commonwealth Secretariat officials would wish to consult your nominated focal point.

Dear Minister,

I thank you very much for your telephone call last Friday 17 July 2020, and for bringing up the pressing issues I mentioned in my letter of 14 July 2020 to the Prime Minister, The Hon Dr Keith Rowley. I also thank you for the warmth and support you have always shown towards the Secretariat.

As mentioned by the Prime Minister, the Commonwealth has a proud history of positive engagement with Trinidad and Tobago regarding election observation, and we are therefore keen to provide the requested election observation support, notwithstanding the challenges posed by the COVID-19 pandemic.

We have potential Observers on stand-by, and my officials have made every effort to put in place potential arrangements, including logistical arrangements, hotels bookings, available flights, etc. to attend to this important invitation. Sadly, I understand that a Focal Point has not yet been communicated and this is essential for the deployment of the mission. Given the current circumstances, it does not seem possible to deploy them by Friday 24 July, as there are critical arrangements that should have been made with the Focal Point prior to deploying.

I remain committed to deploying a Commonwealth Observer Group if the necessary arrangements and protocols can be agreed.

INFORMATION SHEET

1. Trinidad and Tobago's COVID-19 testing requirements

A negative Polymerase Chain Reaction (PCR)-based COVID-19 test is to be presented from a certified institution from the country of departure no more than 72 hours prior to departure. All persons entering Trinidad and Tobago will be subject to quarantine in a State-determined facility. Such persons would be tested upon arrival and before the quarantine period of fourteen (14) days is over.

2. Clear advice on available measures to reduce the risk of exposure to COVID-19 in the country

Trinidad and Tobago follows the COVID-19 public health guidelines of the World Health Organization (WHO), including social distancing, hand washing, wearing of masks and other mechanisms of adopted for proper personal hygiene.

3. Availability and provision of flights into and out Trinidad and Tobago, and the necessary clearances required, if any

Given that Trinidad and Tobago's borders are closed, commercial flights in and out of Trinidad and Tobago are currently not available. As a result, exemption/s for entry of the aircraft/s transporting members of the Observer Group will be required. To facilitate this, the Ministry would require official communication conveying date and time of arrival into Trinidad and Tobago, date and time of departure from Trinidad and Tobago, aircraft model and registration, airport of arrival (North or South terminal of Piarco International Airport), names and passport numbers of crew members. Kindly note that crew members will not be permitted to disembark the aircraft.

Another exemption will be required when the aircraft returns to collect the team for departure. The same information will be required.

On the related matter of travel exemptions for the individual members of the Observer Group, please be advised that the following should be provided:

- A covering letter from the Commonwealth Secretariat advising of the names of the officials comprising the CEOM and requesting travel exemptions for same; and
- Passport biodata pages of all members of the team.

4. Advice and measures in place for COVID-19 management if one or more Commonwealth Observers or staff members develop COVID-19 symptoms or succumb to COVID-19

Trinidad and Tobago has adopted a policy to treat, stabilize, test and discharge all persons, without prejudice towards nationality or any other factors, should individuals in Trinidad and Tobago test

positive for COVID-19 or develop any COVID-19 symptoms. Any person testing positive will be transferred to the Couva Medical and Multi-Training Facility for treatment.

5. Measures that have been put in place to facilitate election observation, namely freedom of movement, and freedom of access to relevant electoral processes and material, electoral actors, inter alia

The Ministry of Foreign and CARICOM Affairs will work alongside all relevant national stakeholders, including the Elections and Boundaries Commission, to facilitate freedom of movement and access to all appropriate processes and material.

6. Designation of a Focal Point from the Ministry of Foreign and CARICOM Affairs to assist with contacts

The Liaison Officer at the Ministry of Foreign and CARICOM Affairs with whom the Secretariat may consult on all matters related to the logistical preparations for the Observer Group is Ms. Reita Toussaint, Permanent Secretary (Ag.), Ministry of Foreign and CARICOM Affairs. I understand that while willing and committed to deploying an observer group here, the Commonwealth Secretariat are finding it challenging to identify sufficient observers able to offer themselves for the extended period required by the 14 day quarantine. They have assembled a team but given the short timeframe could only deploy if the protocols used in recent other regional observer missions are followed - which they understand was C19 testing and a one day quarantine.

No doubt they will be relaying this to you, but it inevitably means the question of funding a 14 day quarantine does not arise.
