Brief Description
<p>The Workshops/Sensitisation activities will enable key stakeholders and members of the public to gain insightful information about the Government's approach to child protection; and educate on ways to prevent and respond to child abuse.</p>
<p>To reduce incidences of school violence; specifically school violence against girls by increasing access to prevention programmes that promote healthy relationships, conflict resolution skills and greater perspectives around gender norms.</p>
<p>Continuation of Education/Sensitization Programme, the initiative will offer online courses (allowing greater reach than in-person activities), a website (name: Childzonett) is to be established to host: 1) All online courses (including 3 new courses); 2) The digital National Child Policy; 3) Online child protection web-based or downloadable games for Primary and teens; and 4) Child resources (videos, brochures, workbooks etc.).</p>
<p>This initiative allows mass communication to the wider citizenry through training and resource access; and will facilitate tracking through built in Monitoring and Evaluation components to report on reach (e.g gender demographics, visits to the page, downloads etc.)</p>
<p>To enable the digitisation of the Child Rights Ambassadors Programme, which educates children on the United Nations Convention on the Rights of the Child. The request includes the cost to procure a consultant to develop the website, content creation and hosting for one year.</p>
<p>A comprehensive stakeholder engagement initiative designed to empower children and young people by celebrating their rights, fostering a sense identity, and advocating for the importance of a nurturing childhood.</p>
<p>The Initiative envisions a 9-month Child Rights and 2-month July-August Vacation Internship Programme. In addition, the establishment of a National Child Engagement Model and handbook on how to engage children in their programming at various levels</p>
<p>This initiative will create an awareness of social issues and trending topics for children and adults such as child abuse, suicide, disabilities and bullying. The information to be presented will assist members of society to gain insightful information and strengthen capacity for protection of children.</p>
<p>Brochures and workbooks will be distributed in information fairs, schools and community residences.</p>

Funding is needed for implementation, monitoring, and evaluation of the following:

- The development and implementation of a national strategy aimed at addressing child poverty and breaking the inter-generational cycle of poverty by ensuring food security and access to social services
- To conduct a comprehensive situational analysis of Children with Disabilities and Special Needs.
- Promoting and enhancing the understanding of abstinence as a choice and informing strategies for healthy implementation. Utilizing all media forms, the strategy will focus on gathering data and transferring the data into the project objective with an outcome of (i) designing and delivering youth-specific messaging relating to sexuality, teenage pregnancy and parenthood and (ii) supporting community-based organisations and other civil society groups working to address these issues.
- To support the development of a National Violence Prevention Strategy
- An impact assessment for strengthening support to Civil Society Organisations to address gaps in service provision.
- Stakeholder sessions focusing on determining information/data gaps in policy making and operation.
- Educational workshops with public sector representatives and civil society organisations.

Training inclusive of management and leadership, records management, bookkeeping and accounting for non-profit organisations, grant proposal writing, course development, project management and facilitation

A programme to build sustainability in the social safety net for former wards of the State through training and education, with an underlying thrust towards the graduation of beneficiaries to independent income earners and wealth accumulators
